# ICANN ASO AC (Address Council)

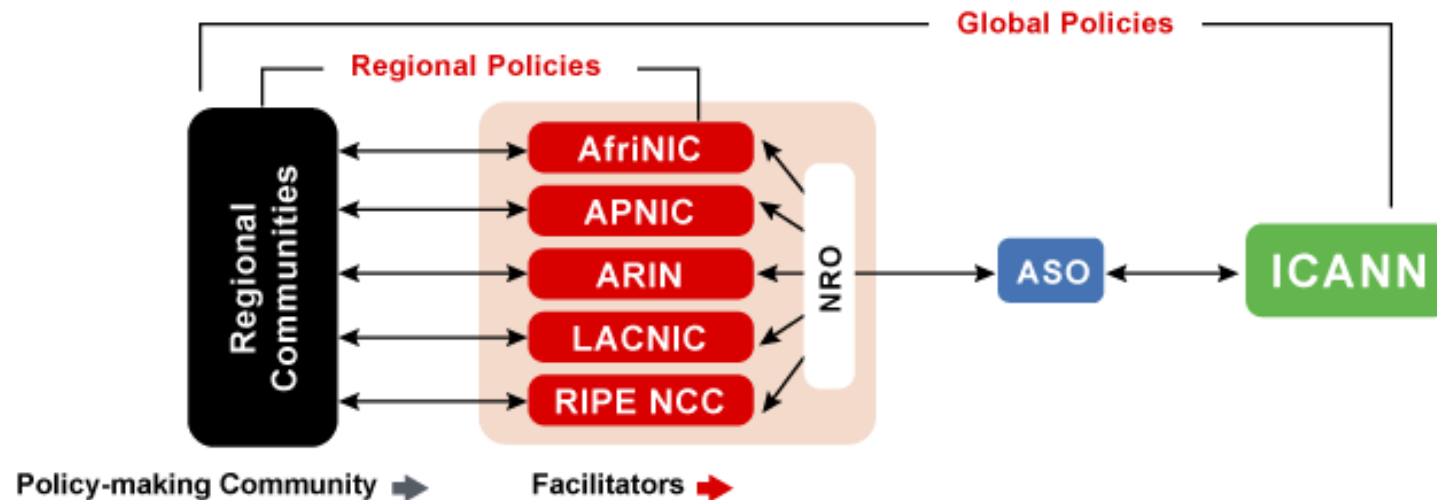
- The NRO Council - Number Resource Policy Advisory Body
- 15 Members (3 from each region)
  - 2 from community for 3-year terms (AFRINIC)
  - 1 appointed by RIR board for 1 year AFRINIC)
  - RIR & ICANN observers also participate
- Advises ICANN Board on matters relating to Internet Numbers
- Selects ICANN Board Members (Seat 9 & 10)
- Selects representatives to ICANN NomCom and Review Teams
- Meets virtually on a monthly basis and physically once a year.

# Global Policy Development



- Global policy proposals are submitted in all 5 regions
- Each region follows its own PDP - All open, transparent, and bottom-up
- Gets passed to the NRO-NC/ASO-AC for review
- Then forwarded to the ICANN board for ratification
- No global policies currently under consideration



# Board Seats & Appointments

- Seat 9 – ARIN Ron Da Silva – 2018 - 2021
- Seat 10 is currently served by Asia Pacific representative Maemura Akinori
  - Recently re-elected (announced March 27, 2019)
- 2 candidates nominated
  - Andile Ngcaba – Nomination withdrawn on 18 February 2019
  - Akinori Maemura
  - Dmitry Burkov
- 3- year term begins at end of ICANN Annual General Assembly during the ICANN 66 Meeting, scheduled from 2-7 November 2019 in Montréal, Canada.
- NomCom 2019, Brajesh Jain, APNIC

# ASO Review

- Process led to 18 recommendations
  - 17 straightforward to implement
  - 18<sup>th</sup> needed consultation – report on survey in Afrinic region published 13 February 2019.
- Annual Face to Face - **Open** (except for discussions regarding the selection of individuals for ICANN roles)
- Monthly Audio Conference Calls – **To be opened shortly to listeners**
- Mailing List Adjustments to move discussion to public archives
  - AC-COORD will be closed and archived
  - New publically archived **AC-DISCUSS** mailing list to replace AC-COORD
